

TO THE SPANISH SECURITIES COMMISSION

Fluidra, S.A. ("**Fluidra**" or the "**Company**"), pursuant to the provisions of section 227 of Royal Legislative Decree 4/2015, of 23 October, which passed the amended text of the Securities Market Act, hereby issues the following:

OTHER RELEVANT INFORMATION

As published by means of the communications (i) of insider information issued (a) on 29 July 2022, with the registration number 1,567 and (b) on 15 December 2022, with the registration number 1,690 and (ii) of other relevant information issued on 23 September 2022, with the registration number 18,370, the Company informs that the deed of Capital Reduction by virtue of which Fluidra's share capital was reduced by a nominal amount of THREE MILLION FIVE HUNDRED THOUSAND EUROS (EUR 3,500,000), through the redemption of THREE MILLION FIVE HUNDRED THOUSAND (3,500,000) treasury shares of one (1) Euro par value each, has been duly registered in the Commercial Registry.

As a consequence of the Capital Reduction, Article 5 of the Company's Bylaws has been amended to read as follows:

"Article 5.- Capital and Shares

The share capital is ONE HUNDRED AND NINETY-TWO MILLION ONE HUNDRED AND TWENTY-NINE THOUSAND SEVENTY EUROS (EUR 192,129,070). It is divided into ONE HUNDRED AND NINETY-TWO MILLION ONE HUNDRED AND TWENTY-NINE THOUSAND SEVENTY (192,129,070) ordinary shares with a face value of one (1) Euro each. All shares have been fully subscribed and paid in and give their holders the same rights."

It is hereby stated that the Capital Reduction has entailed a partial execution of the nineteenth resolution of Fluidra's Ordinary General Shareholders' Meeting held on 5 May 2022, pending from this resolution after such execution the authorization to the Board of Directors to reduce Fluidra's share capital in a nominal amount of up to SIXTEEN MILLION SIXTY-TWO THOUSAND NINE HUNDRED SEVEN EUROS (EUR 16,062,907), corresponding to SIXTEEN MILLION SIXTY-TWO THOUSAND NINE HUNDRED SEVEN (16,062,907) shares of one (1) Euro par value each.

The Company has also agreed to request the delisting of the shares to be redeemed by virtue of the Capital Reduction from the Madrid and Barcelona Stock Exchanges (through the Spanish Stock Exchange Interconnection System - Continuous Market).
